

#### Review racing season 2022 / 2023

In order to further increase the collaboration between the Tether Race Car Association of Australia (TRCAA), the American Model Race Car Association (AMRCA) and the Fédération Européenne du Modélisme Automobile (FEMA), it is the intent from all three Associations / Fédération, to organise each year a designated international race on each continent, with the aim to gather as many friends from around the world and race with each other.

- The TRCAA aims to organises an international race in March / April as kind of racing season opening event.
- The FEMA organises usualy the European Championship in late July, beginning of August and gladly welcomes guest drivers from around the world.
- The AMRCA aims to organises an international race in erally November as kind of racing season closing event.

The race calendar on www.speedmodelcar.org will reflect those races.

#### Closing tracks

- Due to different reasons such as property sold to third party, use of property revoked and planed for different use, lack of members to maintain the race track, our sport lost or will lose soon the race tracks in Gallarate,
   Monza and Gävle.
- The above-mentioned closings are sadly due to a lack of members in the respective clubs, a lack of solidarity to help each other or the lack of initiative to keep our sport alive and could all have been avoided.
- It is my personal regret that we as speedmodelcar community were not able to safe these race tracks, as any
  race track is the nucleus to keep the sport alive and find new members.
- It must be in each FEMA member states intrinsic interest to promote our sport and keep it alive.
- With the example of the FEMA members Great Britain or Lithuania, it is clear that it is never too late to bring our sport back and thriving. Sometimes it needs only the lead and enthusiasm from one or two persons who can motivate, lead and gather the support from others who then help to bring the sport back.
- Therefore, identifying these leaders and accruing new members will and has to be the main focus for the FEMA and all FEMA members from now on.



#### **FEMA Accounting Report**

Following our appointment we have checked all financial statements and balances, completed by 31.12.2022 and set as follows :

The interim balance of the previous year under revison correspond.

The items and documents were examinded by random checks.

Assets and liabilities are proberly valued and recognized.

The accounts comply with the statutes, the accounts are kept proberly and clearly.

The annual profit is EUR 146.95, the revenues are EUR 2'890.—and total assets account to EUR 16'895.66.

Based on the results of our examination, we advise the general meeting, to approve the FEMA Financial Statements 2022 and to relieve the responsible bodies.







In light of the above mentioned (WMCR / FEMA rules harmonization), the FEMA Board suggests that these rules will be voted again until 2028 and no changes will be possible, unless the WMCR proposal is adopted or security issues arise.
