3.1.1 Proposal from TRCAA

Is there any easier way to align WMCR technical rules with FEMA, ie. adopt FEMA rules with some relatively minor deletions.

After a short discussion the WMCR board agreed to the following:

- FEMA's Technical Secretary Rain Teder will send the technical document (Word file) to President Director WMCR, Robert BUCKLEY.
- President Director WMCR, Robert BUCKLEY (lead), in support with Director WMCR, Nicolas TUCCI, and FEMA Technical Secretary, Rain Teder, adjust the existing FEMA rules to create a proposal for the new WMCR technical rules/regulations.
- First draft to aimed for at the EC in Basel (July 2023).

3.1.2 Proposal from TRCAA

Review necessity for WMCR fees. Reconsider calculation of fees to equitably reflect numbers of clubs/countries contributing.

The WMCR Board discussed the need for WMCR fees. All members agreed that there will be no further subsidies to clubs hosting the World Championship starting 2023. The organizing club will revert to be self funded.

3.1.3 Proposal from TRCAA

Review of electric car classification direction.

Statement AMRCA

Roger Phillips had a vision 15 years ago to create electric classes that would be adopted in USA and possibly worldwide. His rules were modeled after WMCR framework with that in mind. Along the way, and since Roger's passing others have shown interest in electrics in USA. Some of these efforts have been to modify (electrify) existing AMRCA cars and classes. As these cars are not found outside the USA, these efforts probably will not improve participation on the international level. Over all, electric participation in USA remains low and divided in focus, neither leading towards a well defined effort to support international competition.

3.1.4 Proposal from TRCAA

Generation of ideas worldwide on obtaining and holding new members.

Every club is responsible for recruiting his own members. The WMCR Board recommends the following activities, which have proven to be successful in different clubs:

- Use social media to attract attention;
- Organize "open days" to show/explain interested people our hobby;
- Post announcements of upcoming races locally (e.g. in malls, schools, etc.).

3.1.5 Proposal from TRCAA

Develop a protocol for more regular WMCR Director communication.

Decide on a preferred method.

The WMCR Board agrees on having a video call every six months.

The first WMCR video call is scheduled for Sunday March 5th, 2023.

3.1.6 Proposal from TRCAA

A reminder that all speeds transmitted to speedmodelcar website must be only those set at WMCR sanctioned events as listed at the beginning of each year. ie. not practice runs (where most of us seem to record our fastest times!)

3.2.1 Proposal from FEMA concerning WC subsidies

So far the organizers of the World Championship have received EUR 2,000 from the WMCR cash register. However, America, Australia and Europe pay EUR 200 per year. So the WMCR cash register only has EUR 1,800 available. The remaining EUR 200 were paid privately by Paul-Otto Ströbel. The new WMCR cash register, Daniela Schmutz cannot and does not want to pay the missing EUR 200 out of her own pocket. According to the WMCR protocol from 2019, EUR 1,800.00 is planned for the organizer.

The WMCR Board discussed the need for WMCR fees. All members agreed that there will be no further subsidies to clubs hosting the World Championship starting 2023. The organizing club will revert to be self funded.
